DIRECTION GOVERNING FACILITIES TO BE EXTENDED TO PERSONS WITH DISABILITIES (दिव्यांग)

Whereas, the Government of Maharashtra with a view to extend the special facilities to the Persons With Disabilities (दिव्याग) has issued orders vide G.R. No. Misc-2016/PK/302/UE-3 dated 4th March 2017

AND

Whereas, the subject matter has to be approved by the Academic Council and Board of Management of the College.

Whereas, to give effect to the orders of the Government, therefore, the Principal of the College as Chairman of the Academic Council do hereby issue the following Direction :-

- The Direction may be called "Direction Governing to extend special facilities to the Persons With Disabilities (दिव्यांग) in an examination of the College.
- 2. This Direction shall come in to force with immediate effect.
- In this Direction, the categories of Persons With Disabilities (दिव्यांग) are as under :-
 - पूर्णतः अंघ (Blindness)
 - अंशतः अद्य (Low vision / Partial Blind) 3.
 - कुष्ठरोग निवारित (Leprosy Cured Persons)
 - कर्णबिघर (Hearing Impairment deft and hard of hearing) लोकोमोटर डिसेबिलिटी अस्थिव्यंगासह (Locomotor Disability Including Orthopedic

 - uisability शारिरीक वाढ खुंटणे (Dwarfism) बौध्दिक अक्षम (मतिमंद / गतिमंद) (Intellectual Disability Mentally challenged/Slow

 - मानसिक आजार (Mental Illness) स्वमग्न (Autism Spectrum Disorder)

 - स्वगन (Autism Spectrum Disorder) सेरेबल पाल्सी (Cerebral palsy) स्नायुंची विकृती (Muscular Dystrophy) मज्जासंस्थेचे तीव आजार (Chronic Neurological Conditions) अध्ययन अक्षम (Specific Learning Disabilities) बहुविष द्धन अपदयरर (Multiple Sclerosis) माषण (वाचा) व माषा अक्षमत्त्व (Speech and Language Disability) खेलस्सीमिया (Thalassemia) / कॅन्सर (Cancer)

- 21. पार्किसन्स आजार (Parkinsons disease)
- Following facilities are to be provided to the examinee, falling in any of the 21 categories as mentioned above.
 - a) Answer papers of "दिव्यांग " examinees shall have to be stamped as 'PWD" at the top centre of the Answer paper. Such answer papers shall be kept separately for evaluation.
 - b) "दिव्यांग " students shall be provided 20 minutes per hour extra time, over and above the stipulated time for all types of examinations including Internal, External, Theory & Practical.
 - i) In the examination, an examinee / student shall be eligible for award of maximum Grace Marks not exceeding 3% of the total Aggregate marks prescribed for that examination.
 - ii) When an examinee fails to score the minimum passing marks in one or more than one head of passing, these 3% of total aggregate marks shall be admissible in one subject or shall be distributed over several subjects as per requirement.
 - iii) This distribution of Grace Marks shall be subject to maximum permissible Grace Marks of 3% of aggregate marks of a particular examination.
 - iv) The award of Grace Marks shall be reflected in the Grade Card with an indication that Grace Marks are only for passing the examination.
 - The provision of this Direction regarding award of Grace Marks shall not be available for seeking exemption(s) in one or more subject(s).
 - vi) An examinee passing the examination with Grace Marks, shall not be eligible to place in the Merit List and shall not be eligible for any College Scholarship/Medal/Prizes or any other College Award on merit pertaining to that examination.
 - d) "বিআৰ "examinee can avail the facility of Writer/amanuensis or Sign Language Interpreter with the prior permission of the Principal wherever applicable. The arrangement of Writer or Sign Language Interpreter shall be made by the parent of the student in coordination with the College Authorities. The request for facility of Writer or Sign Language Interpreter should be made along with the examination form itself.

Provided that the qualification of Writer shall be lower than qualification of the examinee appearing for the examination.

- e) Students falling under Person With Disabilities shall be evaluated using suitable means in the examination conducted by Physical Education Department for award of Grade in Credit/Audit subject(s).
- f) Examiners shall not deduct marks on the ground of spelling, grammar etc. for such examinee(s).
- g) Provisions in Ordinances/Regulations with regard to attendance/detention will not be binding on such students provided, if they get prior permission of the Principal.
- Examinee falling under any of the 21 categories mentioned under para 3 above, shall have to make an application stating the category with supporting documents duly issued by the competent authority and countersigned by the Civil Surgeon to the Controller of Examinations for availing special facility under that category one month before start of examination.

Upon the promulgation of this direction, the provision made earlier in respect of writer/time shall stand repealed.
