Agenda 1: Review/Confirmation of Minutes of previous IQAC Meeting

Member Secretary, IQAC presented the Minutes of the previous IQAC Meeting dated 23/06/2021. All members unanimously confirmed and approved the minutes of the previous meeting.

Agenda 2: Action Taken Report of previous IQAC Meeting

Member Secretary, IQAC presented the Action Taken Report of the previous IQAC Meeting dated 23/06/2021. All members unanimously approved the Action Taken Report.

Agenda 3: Stakeholders Feedback Analysis (Session 2020-21)

Structured feedback process is in place to seek feedback response from Stakeholders' including Alumni, Employer, Parent, Faculty and Student (Exit Feedback) to get useful insights for the enrichment of the curriculum .General Suggestions are also invited during feedback. The feedback analysis is carried out by all departments and the suggestions are recorded and corrective actions are initiated whenever requirements are identified.

Member Secretary, IQAC presented the overall statistical analysis of the stakeholders' feedback department wise and requested to increase the number of responses specifically from Employers' to derive meaningful information from the analysis. All heads of the departments and career development & placement cell were requested to formulate proper mechanism for seeking feedback from Employers. From the overall analysis, the suggestions and observations were stated.

As per the suggestions and observations derived from the Stakeholders Feedback analysis, the concerned departments were asked to initiate necessary remedial measures.

Agenda 4: Student Satisfaction Survey (Session 2020-21)

Student Satisfaction Survey Analysis for Session 2020-21 was presented by Member Secretary, IQAC. The parameters of Student Satisfaction Survey are based on the teaching and learning process of the Institute. From the overall analysis, the suggestions and observations were stated.

The analysis of Student Satisfaction Survey based on the teaching and learning process parameters of the Institute was noted by the house. As per the suggestions and observations derived from the Student Satisfaction Survey analysis, the departments were asked to initiate necessary remedial measures.

Agenda 5: Value Added Courses Policy

Dr. M.B.Chandak, Dean Academics presented the value added courses policy (Annexure I). He informed that valued added courses can be designed to provide necessary skills to increase the employability quotient and equip the students with essential skills to succeed in life. He presented the guidelines for conducting the value added courses to be followed by all departments offering such courses. The members deliberated on the specific guidelines related to blended mode of conduction, student enrolment and evaluation and it was decided that the number of students, evaluation pattern and grading for the value added course be decided by the concerned head of the department.

The House unanimously approved the policy with the resolution that the student enrolment, evaluation pattern and grading for the value added course will be decided by the concerned head of the department.

Agenda 6: Report on Vision 2030 Strategic Plan

Dr. Rupesh Pais, HOD, Management Technology presented a report on Vision 2030 Strategic Plan and its development process. He discussed the activities carried out to build up the strategic plan. He informed that further following activities would be executed and the Vision 2030 Strategic Plan document will be completed within three months.

The house appreciated the efforts taken by the Strategic Planning Committee for preparing the draft Vision 2030 Strategic Plan and resolved to review after three months.

She also informed the house that additional quality parameters are incorporated from session 2021-22 and separate targets are framed in consultation with all heads of the departments for first year, UG and PG departments.
