Agenda 3: Students Satisfaction Survey Report

Member Secretary, IQAC presented the Students Satisfaction Survey Report for 2022-23 based on the teaching and learning process of the Institute. The survey analysis indicates that all of the attributes associated with the teaching and learning process are consistent and the house deliberated to evolve more insightful information to further improve the process.

Agenda 4: Implementation of Interdisciplinary Curriculum: NEP2020 Perspective

Dr. M.B. Chandak, Dean Academics presented the salient features of the cohesive curriculum framed as per the guidelines of NEP 2020 integrating multidisciplinary courses to be implemented from 2023-24. The flexible curriculum includes credit-based courses and projects in the domains of community engagement and service, environmental education, liberal arts and value-based education.

IQAC noted the same and urged all heads of the departments to promote cooperation and coordination between disciplines to implement multidisciplinary education.

Agenda 5: Placement Policy

Dean CDPC ,Dr. Parag Jawarkar presented the details of the placement policy for the students of UG/PG programmes highlighting the proper procedure, skillset, and preparation required to be implemented from 2023-24. Roadmap for enhancing the quality of placements by Career Development and Placement Cell was also discussed.

IQAC resolved to identify the performance measures in order to improve the quality of placements and gauge their social impact. The policy was accepted for implementation from 2023–24.

Agenda 6: Report on Quality Objective Parameters achieved (2022-23) and Quality Objective Parameters targets for session 2023-24

The ISO process for continuous monitoring includes established quantifiable key quality objective parameters, and IQAC reviews how effectively each department is performing against these requirements.
