- (c) College Share - 33.33%.(after deducting expenses related to material purchase, travel expenses etc.)
- (d) Remaining amount will be earning of the Consultant and his team, if any,

Sub : Consultancy/Testing Norms for the academic year 2009-10.

Consultancy/Testing norms for the College are approved in the L.M.C. meeting held on 15th June, 2009 and are as follows:-

- (1) **Personal Consultancy - No College facilities are used:**
 - (a) College Share – 25%
 - (b) Standard deduction such as payment to Account Section, Principal and H.O.D. 1% each.
 - (c) Remaining amount will be earning of the Consultant and his team, if any.
- (2) **Testing, Consultancy where College infrastructure is used:-**
 - (a) College Share – 50%
 - (b) Standard deduction such as payment to Account Section, Principal and H.O.D. 1% each.
 - (c) Remaining amount will be distributed as proposed by H.O.D./Coordinator of concerned department
- (3) **Conduction of outside Program on the Campus such as Entrance Examination of outside organizations, conduction of Tests, Interviews etc.**
 - (a) College Share 50%
 - (b) Standard deduction such as Principal, Account Section – 1% each
 - (c) Remaining amount will be distributed among the concerned staff as proposed by Chief Coordinator and approved by Principal.
- (4) **Engineering Entrance Examination Educative Centre (E⁴C)**
 - (a) College Share – 40%
 - (b) Standard deduction such as Principal, Account Section – 1% each
 - (c) Remaining amount will be distributed to concerned staff as per the guidelines fixed by the Review Committee under the Chairmanship of Shri Govindlalji Agrawal, Secretary, Committee members consisting of (1) Shri Rajendra Purohit, Jt. Secretary, (2) Director, (3) Principal, (4) Vice Principal and (5) Chief Coordinator of E⁴C.
 - (d) This distribution will be effective from 2010 session.

From (1) to (4) regarding consultancy norms, in case of any discrepancy/clarification the decision of the Hon'ble Director will be final.

(5) **Admission Committee:**

- (A) **College admissions:** Rates of payments will be reviewed every year by Review Committee under the Chairmanship of Shri Govindlalji Agrawal, Secretary. Committee members are (1) Shri Rajendra Purohit – Jt. Secretary, (2) Director, (3) Principal, (4) Vice Principal, (5) Dean Admission (6) Dean International Cell.

(B) Application Receiving Centre

The above Review Committee will finalize the rates of payment to the Staff.

- (C)** Apart from the above mentioned works any outside work which is not covered under above mentioned heads, Review Committee will decide the distribution.
